3. Local plan– Swale to build 10,000 houses

Sian gave an outline of the proposed future building plans. Council agreed that we are against the Scenario 3C shown in the report "The Swale Borough Council Choices for Housing Growth by Peter Brett" which would result in a settlement on the Ashford Road. Action: Clerk to email the person organising feedback on the local plan and cc in Colin Prescott with the following: Throwley Parish Council have discussed Scenario 3C of the local plan and are opposed to the development due to the challenges we see with developing the appropriate infrastructure in the area.

- 4. Finances update
